Mr. Jones hereby provides notice that any prior waiver of any of these rights is hereby immediately revoked, and any consent or permission granted waiving any of these Constitutional rights is likewise hereby revoked. Please direct any and all requests for any waiver of these Constitutional rights solely to his attorneys.


In support of this notice and declaration, JERRY WILLIAM JONES relies upon the Fourth, Fifth, Sixth, Eighth and Fourteenth Amendments to the United States Constitution, Article I, § I, ¶¶ I, II, IV, V, VII, IX, X, XI, XII, XIII, XIV, XVI, XVII, XVIII, XXIV and XXVIII of the Constitution of the State of Georgia, international law, as well as statutory and jurisprudential authorities cited below, and all other applicable constitutional, statutory, treaty, customary international law, evolving

international standards, and jurisprudential authority. Defendant further asserts his right to a full and fair hearing on all issues according to both State and Federal Constitutional Law.


This assertion of rights regarding not permitting searches shall include, but is not limited to, jailers and deputy jailers, members of the Georgia Bureau of Investigations or Georgia State Patrol, members of the County Sheriff's office, local city police officers, members of the District Attorney's office, members of the Attorney General's office, members of any other state, county, city, or government agencies, and any and all agents of the foregoing, including persons within the jail, fellow inmates and members of the print and broadcast media who may or may not be urged by law enforcement officials to engage defendant in conversations.
