AND PHOTOGRAPHING EQUIPMENT PURSUANT TO RULE 22
OF THE UNIFORM SUPERIOR COURT RULES**

Pursuant to Rule 22 of the Uniform Superior Court Rules, Georgia Television Company, d/b/a WSB-TV ("WSB-TV") and The Atlanta Journal-Constitution (collectively "Movants"), hereby respectfully request permission to utilize recording and photographing equipment to record the August 11, 2006 hearing in the above-captioned case.

Consistent with the provisions of the rules and guidelines, Movants seek permission to install one still camera and one video camera with microphone in the courtroom in a location that meets the approval of the Court. The hearing that Movants desire to record and televise commences on Friday, August 11, 2006, at 1:30 p.m. in the Superior Court of Paulding County before Judge James R. Osborne.




