**ORDER FOR PERSONAL SERVICE**



for jury duty on Tuesday, February 27, 2006, at the hour of 9:00 o'clock  
a.m.

To that end, the Clerk shall promptly deliver to the Sheriff a  
completed *Sheriff's Return* as to each prospective juror who has failed to  
acknowledge receipt of the *Jury Summons* (i.e., failed to timely return the  
completed juror questionnaire to the Clerk) and attached to each *Sheriff's  
Return*, a copy of this *Order for Personal Service* and *Order to Appear*.  
Thereafter, the Sheriff, or his lawful deputy, shall file in this criminal action  
the executed *Sheriff's Return* with the attached *Order for Personal Service*,  
in each instance, on or before the close of business Monday, February 26,  
2007.
