**ORDER SETTING HEARING FOR JUROR DEFERRAL AND  
EXCUSAL REQUESTS**


On January 26, 2007, the Court issued an *Order to Draw Trial Jurors*. As a result of said *Order to Draw Trial Jurors*, it is anticipated that numerous jurors who have been summoned pursuant to the requirements of O.C.G.A. § 15-12-65(b) will request to be deferred and/or excused from the trial of the above-styled action.

Considering the Court's prior ruling on Defendant's *Motion for Special Venire That Represents a Cross-Section of the Community for Personal Service on Those Jurors Who Do Not Respond to Summons, and for the Court to Determine All Excusals* (Defendant's Motion Number 81), wherein the Court previously ruled that it would consider all juror deferral and excusal requests on the first morning of jury duty and authorized the Clerk of Superior Court to grant deferrals as specifically authorized by O.C.G.A. §§ 15-12-1(a)(2), 15-12-1(a)(3), 15-12-1(b), and 38-2-276, upon

further review, the Court has determined that it is necessary to conduct hearings related to the deferral and excusal requests prior to the first day of jury duty.

Accordingly, the Court hereby notices counsel that a hearing on said requests shall occur on **Thursday, February 22, 2007, at 9:00 o'clock a.m.** at the Whitfield County Superior Court. The Clerk of the Whitfield County Superior Court will notify all summoned jurors who request a deferral and/or excusal as to this hearing date and require their attendance.
