ORDER TO DRAW TRIAL JURORS


Pursuant to O.C.G.A. §§ 15-12-40, 15-12-42, and 15-12-120, the Clerk of the Whitfield County Superior Court is hereby directed to draw no less than 250 petit jurors for the trial in the above-referenced criminal action which is scheduled to <sup>re-</sup>commence on Monday, February 26, 2007.

Said petit jurors shall be summoned according to the standards set forth in O.C.G.A. § 15-12-65(b) and shall be required to appear on the 27<sup>th</sup> day of February, 2007 at 9:00 A/m.

The Court specifically notes that drawing the venire is not a critical stage of the proceeding requiring the Defendant's presence. Pope v. State, 256 Ga. 195 (1986), overruled on other grounds by Nash v. State, 271 Ga. 281 (1999).
