ORDER

On December 2, 2003, this Court denied Defendant's motion entitled APPLICATION FOR INDIGENCY AND CERTIFICATE OF FINANCIAL RESOURCES. 
On December 12, 2003, Walker County District Attorney Herbert E. Franklin filed a response on behalf of the State.

Having reviewed the motions of the State and the Defense, this Court ORDERS that a non-jury hearing on the above entitled motion be SPECIAL SET for January 8, 2004 at 10:00 a.m. in the Main courtroom of the Walker County Courthouse. The Court ORDERS all attorneys and the Defendant to be present for said hearing.

The Sheriff of Walker County is ORDERED to serve a certified copy of this Order on the Defendant's wife, Venessa Marsh, at her residence, 228 Center Point Road, Lafayette, GA 30728. Vanessa Marsh is ORDERED to be and appear, on January 8, 2004 at 10:00 a.m. in the Main courtroom of the Walker County Courthouse as a witness.

On November 18, 2003, the Court announced that a decision on the Defendant's MOTION TO DISMISS and GENERAL and SPECIAL DEMURRERS would be issued prior to the end of the year 2003. Both the dismissal and the demurrers continue to be under advisement and the Court will not issue a decision on these pleadings until January 8, 2004.
